

## Collections

- Per CoreLogic, changed the email address which the tax service extract is automatically sent. Also added fields in the Customize screen where users can edit/update the CoreLogic emails and add additional ones if desired.
- Fixed a couple of issues causing tax service file to save incorrectly relating to the save path.
- Corrected typo and verbiage on Certificate of Settlement and Recommitment.
- On lien notices; reduced character limit for the tax payer name on Mortgage Holder and Interested Party copies to correct wrapping issue.

## Motor Vehicle

- Fixed an issue causing the inability to void excise only transactions.
- Fixed a problem with voids not returning plates to inventory.
- Updated Residence codes which will update when a “Check Database Structure” is run.
- Prorated MC registrations that are transferred will now use the full rate to determine prorated fees instead of the previously prorated rate.
- Corrected an issue with class code printing for excise only transactions that were not an AP class.
- Corrected an issue during the BMV update that was causing records to save incorrectly in the database which was in turn causing a problem in the period close out process.
- Sticker fields are now disabled on excise only transactions.
- Updated the validation during a void to ensure the MVR3 entered is the one voided.
- Added a warning on transfers when adding a vehicle to a fleet that a registration cannot both prorate and take credits as a transfer, except in the case of Motorcycles.
- Corrected sticker issues during voids. Only inventory issued with the selected transaction (MVR) will be voided.
- Transfers during a renewal will now give an error if the expiration is more than 6 months away.
- Added error checking during registrations to track lack of records updating in certain cases.
- End of period reports will no longer include the Dealer Sales Tax transactions in the No Fee count. Also, the reports will show the Sales Tax Exempt transactions in the No Fee count if the Use Tax Form was not done on the system.
- Auto posted Rapid Renewal Journals created in succession will no longer create multiple control entries.
- Corrected state report subcategory label for Special Mobile Equipment.

### Payroll

- Added two options to the Deduction setup File Menu to globally update employee deductions and matches. This will allow users to always force employee deduction and match changes to all or some employees based on criteria. If criteria is blank, then all employees will be affected that use the chosen deduction or match. The change made in the "Update" section will be the set deduction or match amounts.
- Updated State 941ME and 941ME UC1 to the 2017 forms which have been approved by the state and the Federal 941 has been updated for 2017 as well.

### Real Estate

- Added "Property Code" to Global Changes.

### Utility Billing

- Added options to the comments report to search by account or date range.
- Broke out location number from the location name on the search screen to allow for easier and more accurate sorting functionality.
- Corrected Lien Discharges to print Town Name correctly on the signature line when printing saved notices.
- Fixed an issue with Utility negative balance status list showing only certain 0 balance liens.
- Updated verbiage on the Disconnect Notices per the PUC.
- Added an option to Customize (Under Bill Options) to Include Meter Change Out Consumption when using the Outprinting File Bill type. Three fields (Meter 1, 2 and 3 Change out) were added to the Outprint file and are now included in the Outprint format.
